

Current Projects and Grants:

Spring Forage Quality Monitoring

For the past 15 years the Central New York Dairy, Livestock and Field Crops team has monitored the quality of first cutting hay crop in the field to give producers a better idea of when they should begin harvest. This prediction of when to cut is based on alfalfa height which works well to predict both alfalfa and grass quality. Growth for 2018 was considerably behind 2017, especially for the May 8 observation, because of cold temperatures. In 2018 May 8 alfalfa was averaging 9 inches tall and 59 percent of the fields were 9 inches or less. In 2017 on May 2 the alfalfa averaged 13 inches tall and 17 percent of the fields were 9 inches or less. This was valuable information because producers in many years need to consider prioritizing starting first cutting over planting but 2018 this wasn't one of them. Although air temperatures were cool reducing forage growth, soil moisture was on the dry side so tilling and planting could continue. (Balbian, Ficken, Ganoe, Gibson, McFarland, and Schmidt).

Montgomery County Agriculture Microenterprise Grant – Facilitator

Assisting in facilitating the Microenterprise Grant with Montgomery County. Responsible for coordinating and overseeing 4 business modules for producers that are awarded the microenterprise grant. Ongoing through Spring 2019. (Tommell)



Monitoring program for soybean producers

Again this summer the team is working with 11 soybean growers to monitor soybean fields for insects and disease. Also this summer an effort is being made to measure residue cover as more growers go to no-till planting of soybeans. The field data will be summarized and presented to the growers in December at a follow up meeting.

NYFVI Grant: Using forage quality testing to improve the corn silage hybrid selection process on dairy farms

For this grant 6 additional samples were taken this spring that were inaccessible when our initial fermented samples were taken back in January. In some instances, they represented a different crop year. A final set of fresh samples will be taken again in the fall of 2018. (Balbian, Ganoë)

Dairy Acceleration Program (DAP)

Dairy Acceleration Program (DAP) applications continue to come in as this quarter two farms applied for Business Planning. The emphasis of new applications has been changing to resiliency. (Balbian)

Grasstravaganza

Grasstravaganza is a grazing related event being conducted by NRCS. The CNYDLFC has been asked to be on the planning committee and the committee meets approximately every other month. It will be held July 25-27, 2019 at SUNY Cobleskill. (Balbian, Ganoë, McFarland, Tommell)

Monitor insect pests with pheromone traps

Kevin and other CCE educators across the state have put out traps to monitor for insect pests such as black cutworm, armyworm and western bean cutworm. The traps contain a pheromone that attracts male moths to a trap to be counted. Few moths of either black cutworm or armyworm were seen this spring and the trapping changed to western bean cutworm beginning in July. (Ganoë)

Educational Activities

Improved Forage Quality=Increased Profitability\$\$ For Livestock Producers

Ashely McFarland and Kevin Ganoë held discussions on how to better utilize forages to make your livestock production more profitable. Topics included animal nutrient requirements, defining what quality forage is, and cutting management to achieve the desired forage quality.

Emerging Issues and Individual Assistance

Met once this quarter with two different dairy farm profit teams. (Balbian, Tommell)

Individual consultations on dairy farms have dealt with dairy nutrition, facility design & expansion, raising replacements, ventilation, stall design, and dealing with the low milk prices. (Balbian)

Individual consultations on record keeping: records for calving, vaccinations, health issues, rate of gain. Also teaching them to produce a consistent product for their customers, so they will keep their customer's, and proper tools and techniques for vaccinations and castration. (McFarland)

Individual consultations on planting issues related to shallow planting and bird damage and corn and soybeans failing to emerge from compacted soils. Also, lack of nodulation in soybeans, and poor weed control. (Ganoë)

Participated in a training conducted by Jason Karzas of Pro-Dairy for educators looking to utilize the Dairy Farm Business Summary. Assisted Ashley Howlett and Sandy Buxton with Dairy Farm Business Summary Review. (Tommell)

Attended joint Educators Meeting Albany Co CCE. (Tommell)

Utilized webinars, websites, and individual meetings with FSA staff for updates on the revised MPP program (Balbian).

Newsletters and Media

Central New York Dairy Day was covered in the May 7th issue of Country Folks. It was titled *Technology Forging Ahead in the Northeast*. It covered 2 pages and include a large color photo of the speakers. (Balbian)
