<u>New York HERO Act in Effect Now: Employers Required to Activate Plans and Prevention</u> <u>Measures</u>

Employers should immediately: review and update their plans, provide a verbal review of the plan with all employees, provide written copies to employees, and post a copy of the plan in the workplace. Watch Out for the Asian Longhorned Tick!

This invasive species is most active April – October and lives in grassy areas near forests and meadows. They spread bacteria and viruses that cause illness and have quick population growth. You can prevent infestations by avoiding overgrown pasture, keeping wildlife away, and regularly checking livestock for ticks. Learn more here.
