End-of-Season Combine Clean-out Recommendations

For many growers in Southwest New York, fall harvest is coming to an end. Now is the time to prepare harvest equipment for winter storage. Proper post-harvest preparation includes cleaning all parts of the combine, including the head, feeder-house, rock trap, concaves, cleaning shoes, elevators, grain bin, unloading auger, chopper, rear axle, and chassis before entering storage. These can help reduce the likelihood of animals nesting in the equipment which can lead to electrical damage resulting in fire, improves the function and longevity of parts, and puts a closure to the 2020 growing season. A full combine clean-out protocol is available at the North Central Agriculture and Natural Resource Academy. Thinking of Starting a Red Meat Packing Plant in NYS?

2020 has been a challenging year for livestock farmers and red meat packers in NY. With many packers already booked solidly for 2021, livestock farmers are feeling panicked about how to get their animals harvested in a timely way. This has driven unprecedented interest in opening new slaughterhouse facilities in the state. But anyone who does not already have a strong background and expertise in the industry faces a steep learning curve, with high risk and a large investment of money. This free webinar will lay out some of the primary considerations for opening a red meat slaughter and processing facility, from infrastructure to regulations and from labor to financing. Presenter Marty Broccoli of Cornell Cooperative Extension in Oneida County has 40 years of experience in the meat packing industry, and provides technical assistance for new plants in NY. Keith Schrader is a long-time beef farmer who owns Schrader Farms Meat Market, a USDA slaughterhouse in Romulus, NY. Both will share key tips and lessons learned, with ample time for Q&A. Spotted Lanternfly Confirmed Found in NYS

The Spotted Lanternfly, a foreign pest known to be highly destructive in crops including maple trees, apple trees, grape vines, and hops, has been identified on Staten Island, areas of the Hudson Valley, and in the Southern Tier. Monitoring is ongoing, and the public is urged to continue to report findings of the insects and egg masses through the colder months to Ag and Markets at spottedlanternfly@agriculture.ny.gov. Early reporting can help with the development of targeted management plans to slow the establishment and spread of this insect. This program provides direct relief to producers who continue to face market disruptions and associated costs because of COVID-19. If you applied for CFAP 1, you are NOT automatically signed up for CFAP2, you must reapply with your local FSA office.
